RESOLUTION NO. 87- 100

APPROVAL OF AMENDMENT TO THE WATER QUALITY CONTROL PLAN
FOR THE NORTH COASTAL BASIN ESTABLISHING THE EFFECTIVE
DATE OF THE PROHIBITION OF USE OF INDIVIDUAL DISPOSAL
SYSTEMS IN THE WILLOWSIDE ESTATES, SONOMA COUNTY

WHEREAS:

1. The California Regional Water Quality Control Board, North Coast Region (North Coast Regional Board) adopted the Water Quality Control Plan for the North Coastal Basin (Basin Plan) on March 20, 1975.
2. On April 10, 1986, the North Coast Regional Board established a waste discharge prohibition from individual disposal systems in the Willowside Estates area through Regional Board Order No. 86-73.
3. The State Board has found, consistent with the California Water Code Section 13280, that there is substantial evidence in the record that the continued discharge of wastes from individual disposal systems in the Willowside Estates area is causing and will continue to cause contamination and constitutes a threat to public health and water quality.
4. In satisfaction of the requirements of Section 13283 of the California Water Code, the State Board reviewed possible alternatives to prohibiting discharges from individual on-site disposal systems and found that the only option available for this area was to provide a community sewer system.
5. On April 16, 1987, the State Board approved through Resolution No. 87-34 a waste discharge prohibition for the Willowside Estates area, but during the public workshop the State Board voiced concerns regarding the effective date of the prohibition.
6. The proposed amendment as described in North Coast Regional Board Resolution No. 87-59 specifies the effective dates of the waste discharge prohibition in the Willowside Estates area and rescinds Regional Board Order No. 86-73.
7. State Board finds that the modification carried out by the North Coast Regional Board is appropriate and removes any uncertainties with regard to the effective dates of the waste discharge prohibition on the Willowside Estates area.
8. The proposed Basin Plan amendment is consistent with the requirements of Public Resources Code Section 21000 et seq. (California Environmental Quality Act).

9. Basin plan amendments do not become effective until approved by the State Board.

THEREFORE BE IT RESOLVED:

That the amendment to the Basin Plan pertaining to a waste discharge prohibition from use of individual sewage disposal systems in the Willowside Estates area, Sonoma County as adopted in North Coast Regional Board Resolution No. 87-59 on May 28, 1987 be approved.
