RESOLUTION NO. 94-15

APPROVAL OF A STATE REVOLVING FUND LOAN FOR  
THE ELSINORE VALLEY MUNICIPAL WATER DISTRICT FOR  
CONSTRUCTION OF THE CANYON LAKE SEWERS AND PUMP STATIONS;  
SRF PROJECT NO. C-06-4417-110

WHEREAS:

1. The State Water Board on August 18, 1988, adopted the "Policy for Implementing the State Revolving Fund for the Construction of Wastewater Treatment Facilities", and amended it on September 20, 1990, and on January 21, 1993;
2. The wastewater collection system in the Canyon Lake area of the Elsinore Valley Municipal Water District has experienced very high infiltration and inflow which has resulted in sewage contamination of the recreational and domestic water reservoir of Canyon Lake due to sewage overflows;
3. The State Water Board on September 23, 1993, adopted the Federal Fiscal Year 1994 SRF Loan Program Priority List which includes the Elsinore Valley Municipal Water District for remedial replacements, upgrades, and modifications of the collection system and pump stations;
4. The Regional Water Quality Control Board (Region 8, Santa Ana) has issued a Time Schedule Order No. 93-94 for remediation of the collection system to correct the sewage spills;
5. The Division of Clean Water Programs (Division) has approved the project report, environmental documents, draft revenue program, and water conservation plan for the subject project; and
6. The Elsinore Valley Municipal Water District approved and adopted a Negative Declaration (State Clearinghouse No. 93112058) prepared for the project, which has been reviewed and considered and it has been determined that the project will not result in any significant environmental impacts.
7. Upon receipt of California's FFY 1994 capitalization grant, the State Water Board will have sufficient SRF loan funds to make an SRF loan of \$6.10 million to the Elsinore Municipal Water District .

THEREFORE BE IT RESOLVED THAT:

Subject to receipt of the FFY 1994 SRF grant, the State Water Board approves an SRF loan in the amount of \$7.04 million to the Elsinore Valley Municipal Water

District for the construction of the collection system improvements in the Canyon Lake area (SRF Project No. C-06-4417-110), with a repayment period of twenty (20) years and the first annual loan repayment due one (1) year after the completion of construction.
