

STATE WATER RESOURCES CONTROL BOARD
RESOLUTION 94-24

APPROVES THE FEDERAL FISCAL YEAR (FFY) 1994
INTENDED USE PLAN (IUP), AUTHORIZES THE EXECUTIVE DIRECTOR
TO ACCEPT THE FFY 1994 CAPITALIZATION GRANT FOR THE STATE REVOLVING
FUND (SRF), AND ORDERS THE TRANSFER OF MONIES IN THE
STATE WATER QUALITY CONTROL FUND TO THE SRF

WHEREAS:

1. The Division of Clean Water Programs has prepared a draft FFY 1994 IUP in compliance with federal rules, and such plan must be submitted prior to EPA's award of the Capitalization Grant;
2. Congress has appropriated FFY 1994 SRF monies in the amount of \$86,865,075 and the State can now apply for these funds;
3. Authorization to accept the FFY 1994 SRF Capitalization Grant award is needed;
4. Senate Bill No. 497, which became law on January 1, 1994, authorizes the State Water Board to order the transfer of monies from the State Water Quality Control Fund to the SRF for use as the State match as needed; and
5. The FFY 1994 Capitalization Grant requires a State match of \$17,373,015.


THEREFORE BE IT RESOLVED THAT:

The State Water Board:

1. Approves the FFY 1994 IUP and authorizes the Executive Director to accept the FFY 1994 SRF Capitalization Grant;
2. Orders the transfer of unencumbered monies and any future repayments in the Water Quality Control Fund, to the SRF for use as the State match.

I. INTRODUCTION

The State Water Resources Control Board (State Water Board) submits this Intended Use Plan (IUP) to the United States Environmental Protection Agency (EPA). The IUP meets the requirements of Section 606(c) of the Federal Clean Water Act (Act). The IUP is submitted as part of the State's annual application for a Capitalization Grant under Title VI of the Act.

The IUP serves as the planning document for explaining how carryover funds from previous years and the federal fiscal year (FFY) 1994 appropriation for the State Revolving Fund (SRF) will be used. As currently developed, the FFY 1994 IUP identifies the forecasted binding loan commitment amounts and disbursement schedules for all the available funds.

The State Water Board intends to continue with the implementation of the basic loan program as outlined in the State Water Resources Control Board Policy for Implementing the State Revolving Fund for Construction of Wastewater Treatment Facilities (SRF Policy) adopted by the State Water Board on August 18, 1988, as amended on September 20, 1990, January 21, 1993, and on September 23, 1993.

II. PROJECT SPECIFIC INFORMATION

The State Water Board has prepared detailed schedules for binding loan commitments and disbursement of funds for FFY 1994. This information is summarized in the following tables:

- A. Table 1 is a summary of California's share of the FFY 1994 appropriation.
- B. Table 2 is a summary including a listing of projects by federal Capitalization Grant which the State Water Board expects to issue binding loan commitments to in FFY 1994.
- C. Table 3 is a summary including a listing of the project disbursement schedules for each Capitalization Grant for FFY 1994 and beyond.
- D. Table 4 is the schedule for estimated increases in the Automated Clearinghouse (ACH) ceiling for FFY 1994 funds.

III. LONG- AND SHORT-TERM GOALS

Both long- and short-term goals are essential to the implementation of a successful SRF Program. A long-term goal is one which covers a five-year period. Short-term goals are those that are expected to be accomplished during FFY 1994.

A. Long-Term Goals

- 1) To achieve statewide compliance with water quality objectives.

- 2) To bring Publicly-Owned Treatment Works (POTWs) into compliance with federal requirements.
- 3) To perpetuate the SRF.
- 4) To maximize the ability of the SRF to assist local government in constructing needed water quality control facilities.
- 5) To obtain approval of the Clean Water Bond Law of 1994 in order to provide funds for the State match requirement for future Capitalization Grants.
- 6) Provide assistance for implementation of the State Water Board's nonpoint source management plan.

B. Short-Term Goals

- 1) Apply for and receive the FFY 1994 Capitalization Grant within the first year of the allotment period. This will enable California to receive any reallotments of SRF monies.
- 2) To fund projects in FFY 1994 that will enable local agencies to abate public health and water pollution problems.
- 3) Provide consultation services to small loan applicants in order to expedite the processing of their loan requests. Assistance will include guidance for identifying project alternatives, selecting the cost-effective alternative, preparing the Project Report, the Revenue Program, and the Environmental Assessment. Assistance will also be offered to aid municipalities in assuring that they have the ability to properly administer and manage their project.
- 4) To investigate the feasibility of accelerating the issuance of binding loan commitments in order to better assure compliance with the minimum binding loan commitment schedule.

IV. RELATIONSHIP BETWEEN THE SRF AND OTHER STATE FINANCIAL ASSISTANCE PROGRAMS

The State Water Board administers two other programs that provide financial assistance for wastewater treatment. These are:

- A. A State funded Small Communities Grant Program which provides up to 97.5 percent grant funding for a qualifying project. The maximum grant is \$2 million. The State may provide loan assistance from the SRF for the local share of these State grant funded projects.
- B. The Water Reclamation Account created by the Clean Water Bond Law of 1984 provides \$25 million for the construction of water reclamation facilities. This is a perpetual revolving fund loan program similar to the SRF but capitalized by State funds only. A sum of \$40 million is also provided from the Clean Water and Water Reclamation Bond Law of 1988 for construction of water

reclamation facilities. Loan funds under this program are not revolving. Principal and interest repayments are returned to the State's general fund.

V. INFORMATION ON THE SRF ACTIVITIES TO BE SUPPORTED

Projects involving secondary treatment (Category I), advanced treatment (Category II), infiltration/inflow (I/I) correction (Category IIIA) Major sewer system rehabilitation (Category IIIB), new collection systems (Category IVA), new interceptors (Category IVB), combined sewer overflow correction (Category V), and storm drainage (Category VI) are eligible to be funded under the loan program. In addition, activities and projects necessary to correct nonpoint source and estuary pollution problems and to construct water reclamation facilities are eligible for loan assistance.

A. For FFY 1994, the State Water Board proposes to provide loan assistance as follows:

- 1) Category I--Secondary Treatment; Category II--Advanced Treatment; Category IIIA--I/I Correction; Category IVA--New Collection Systems; Category IVB--New Interceptors and Appurtenances; and Category V--Combined Sewer Overflow will be funded by the SRF. Included in these categories will be water reclamations projects.
- 2) Category IIIB--Major Sewer System Rehabilitation will not be funded in FFY 1993.
- 3) Category VI--Storm Drainage projects.
- 4) Nonpoint source and estuary enhancement programs and projects.

B. Types of assistance to be provided (e.g., loans, guarantees, or insurance).

Only loans under the basic loan program will be provided in FFY 1994. The basic loan program provides for loans at one-half the interest rate of the most recent sale of State General Obligation Bonds. These loans must be completely amortized within twenty years of project completion. Some of the loans issued in FFY 1994 may involve the refinancing of existing local debt.

Projects funded with FFY 1994 Capitalization Grant monies will be required to meet equivalency requirements. The State match is provided by funds transferred from the Water Quality Control Fund Account and loans issued under the 1984 Water Reclamation Account. The previously funded reclamation projects are considered to be non-equivalency projects and are designated as such on the FFY 1994 Chart in Table 3.

C. State Water Board policies on implementation of the SRF Loan Program (e.g., eligible costs, program requirements, repayment schedules).

The State Water Board's Policy (see Appendix 2 of the Operating Agreement) contains the detailed information on the requirements for obtaining an SRF loan for wastewater treatment projects. Additional policies or regulations will be developed for inclusion in the Operating Agreement to cover administration of loans for nonpoint source, storm drainage, and estuary enhancement projects and activities.

VI. ASSURANCES AND PROPOSALS

A. Environmental Review Certification

The State Environmental Review Procedures (SERP) are outlined in the Operating Agreement and the Policy for Implementing the State Revolving Fund Loan Program (see Appendix 1 of the Operating Agreement for review specifics). The SERP is the EPA approved environmental review process which is considered equivalent to National Environmental Policy Act under Title VI of the Clean Water Act.

B. Binding Commitment Certification

The State certifies that it will enter into binding commitments equal to at least 120 percent of the cumulative quarterly Capitalization Grant ACH increases within one year after receipt of each ACH increase. Table 2 contains a projected summary for FFY 1994, and displays the projects scheduled for binding commitments by quarter for each Capitalization Grant. We are expecting to issue \$206.3 million in binding loan commitments in FFY 1994.

A total of \$28,002,007 is expected to be credited to the repayment account in FFY 1994. Funds in the account at the beginning of the fiscal year total \$37,942,892. No binding loan commitments or disbursements are expected to be made in FFY 1994 from the repayment account.

C. Expedited and Timely Expenditure Certifications

The State certifies that it will expend all funds in the SRF in an expeditious and timely manner. Table 3 is a summary of the projected SRF disbursements by Capitalization Grant for FFY 1994. The Table also includes the individual project disbursements for FFY 1994 and beyond.

The State Water Board is using the 1984 Water Reclamation Account for part of the State match for FFY 1994 federal funds. The remainder of the State match will be from the transfer of an estimated \$14,915,330 from the Water Quality Control Fund Account.

D. First Use for Enforceable Requirements Certification

California has satisfied the First Use Requirement.

E. Compliance with Title II (Equivalency Requirement)

All treatment works projects funded in FFY 1994 will be required to meet designated Title II requirements (see Appendix 2 of the Operating Agreement). The State will bank all State funds spent on projects in FFY 1994 meeting Title II requirements in order to buy out the equivalency requirement as early as possible.

F. Transfer of Construction Management Assistance Grant (CMAG)

No CMAG funds provided under Section 205(g) of the Act will be transferred to the SRF for administration. The State will administer the loan program using the allowed four percent of the Capitalization Grant.

G. Loan Defaults

California will make every effort to assure that loan recipients repay their loans. In the event of any defaults, the Division of Clean Water Programs will have our Revenue Program Specialist review the agency's user charges and budget and make recommendations for assuring continued loan repayments. California will also take whatever other steps are required, including judicial action, to assure timely repayments of loan obligations. As a last resort, California will use the intercept provision in State law to recover lost funds should the State Water Board fail to resolve the default.

H. State Match

California will provide the State match in cash at the time it makes a cash drawdown under the federal ACH procedure. A portion of the State match will be made by using \$2,457,685 in previously issued loans under the 1984 Water Reclamation Account. The remainder of the State match (an estimated \$14,915,330) will be provided by transferring cash from the Water Quality Control Fund Loan Account to the SRF. The overall State match percentage for FFY 1994 will be 14.30891.

I. Letter of Credit Ceiling

Table 4 is the proposed schedule for increasing the ACH ceiling amount for FFY 1994 federal funds.

VII. METHOD AND CRITERIA FOR THE DISTRIBUTION OF SRF FUNDS

A. Criteria and method for determining the types of funding distribution to be provided.

The task of predicting which project will be ready for construction on a given date is very difficult at best. The IUP identifies a total of \$95,305,802 in federal dollars (See Table 1) that will be available in FFY 1994 for loan assistance. Table 2 is a list of binding loan commitments the State Water Board expects to make in FFY 1994 from all available funds. The adopted and EPA approved FFY 1994 Priority List identifies projects which will compete for loan assistance in FFY 1994.

B. Criteria and method for selecting specific projects to be funded.

Projects to be funded in FFY 1994 are determined in accordance with California's Clean Water Grant Priority System which has been approved by EPA. The State Priority System is based on public health and water quality considerations as described in Appendix 2 of the Operating Agreement. Included in the State Priority List System are bypass provisions.

The fundable portion of the list for FFY 1994 will include Priority Classes A, B, C, and D projects which are projected to proceed to construction in FFY 1994. Loans will be issued to projects on the fundable portion of the list after receiving a preliminary loan commitment from the State Water Board. The preliminary loan commitment is made by the State Water Board on a first-come, first-served basis for those projects completing facilities planning. The federal fiscal year will be used for California's SRF Loan Program.

VIII. PERPETUATION OF THE SRF

California will charge an interest rate equal to one-half the rate of the most recent sale of State General Obligation Bonds. The State will also take whatever actions are necessary to recover loan funds should a loan recipient default on its loan repayments. Refer to the Operating Agreement for a more detailed discussion of the specific actions.

X. ADMINISTRATIVE COSTS

Based on the appropriation for FFY 1994, California will apply for a \$86,865,075 Capitalization Grant which includes \$3,474,603 for administration of the loan program.

XI. MARKET LOAN RATE

California will issue loans at one-half the interest rate on the most recent sale of State General Obligation Bonds. This rate will always be below the market rate. Because of this fact, a market survey will not be conducted.
