STATE WATER RESOURCES CONTROL BOARD RESOLUTION NO. 94-66

APPROVAL OF \$300.000 FROM THE STATE WATER POLLUTION CLEANUP AND ABATEMENT ACCOUNT FOR AN ASSISTANT TO THE SAN DIEGO INTERAGENCY WATER QUALITY PANEL

WHEREAS:

- 1. In 1987 legislation (AB 158), the first five year interagency panel was created to promote better communication between organizations on San Diego Bay matters, to advise the Regional Water Quality Control Board (RWQCB) of San Diego Bay water quality information, and to publish annual reports to the State Water Resources Control Board (SWRCB) and Legislature; and
- 2. In 1992 legislation (SB 1525) was introduced to extend the interagency panel (panel) an additional five years with similar goals, but with the additional requirement of issuing a Comprehensive Management Plan for San Diego Bay (Plan); and
- 3. Components of the Plan would include coordination of monitoring to detect waste discharges, determination of effects of waste discharges on beneficial uses, assessment of mitigation measures based on a broad knowledge of beneficial uses, and identification of cleanup options; and
- 4. The RWQCB has been mandated lead agency, with the chairman of the RWQCB to serve as chairman of the panel; and
- 5. No funding was introduced to support panel activities; and
- 6. The RWQCB has requested \$300,000 from the State Water Pollution Cleanup and Abatement Account (Account) to assist the Chair of the panel over four fiscal years to complete the Plan by 1977; and
- 7. The efforts of this assistant to the panel will allow the RWQCB to achieve three objectives under the mandated Bay Protection and Toxic Cleanup Program:
 - a. Issue a Regional Cleanup Plan by 1998, and
 - b. Initiate reevaluation of waste discharge requirements within 120 days of ranking toxic hot spots in the regional cleanup plan; and
 - c. Assist the efforts of the San Diego Bay Regular Review Committee which was established as a subcommittee of the Interagency Panel by terms of a settlement agreement in an action entitled Environmental Health Coalition v. SWRCB (Case No. 644648, County of San Diego Superior Court); and
- 8. In 1987 the SWRCB provided \$191,720 from the Account for the five year San Diego Bay Cleanup Project which was primarily a sediment chemistry sampling effort which targeted deposits of industrial waste from point sources.

THEREFORE BE IT RESOLVED THAT:

The State Water Resources Control Board hereby approves the RWQCB request for up to \$287,000 disbursed over four years, from the State Water Pollution Cleanup and Abatement Account to assist the Chair of the San Diego Interagency Water Quality Panel.
