STATE WATER RESOURCES CONTROL BOARD RESOLUTION NO. 94-78

APPROVAL OF A REQUEST TO USE UP TO \$200,000 FROM THE EMERGENCY, ABANDONED, RECALCITRANT (EAR) ACCOUNT AT THE JOHN RIDDELL SITE LOCATED AT 4660 HESSEL ROAD IN SEBASTOPOL, SONOMA COUNTY

WHEREAS:

- 1. The Executive Officer of the California Regional Water Quality Control Board, North Coast Region (Regional Water Quality Board), submitted a written request to the Chief of Clean Water Programs for Prompt Action funding in an amount not to exceed \$200,000 from the Emergency, Abandoned, Recalcitrant (EAR) Account for the prompt cleanup of petroleum contaminated groundwater, caused by leaking underground storage tanks located at 4660 Hessel Road in Sebastopol, that has impacted a drinking water well and threatens additional shallow domestic wells located in close proximity of the site.
- 2. Prompt action by the Regional Water Quality Board to abate the situation is necessary to protect human health and the environment:
- Funds are available from the EAR Account, established under SB 2004 (Underground Storage Tank Cleanup Fund Program), if the State Water Board authorizes their use;
- 4. The Regional Board issued Cleanup and Abatement Order 94-74 on May 10, 1994; the date for compliance with that order will expire on August 1, 1994; and, the responsible parties do not have the financial resources to comply with the order.
- 5. Section 25299.51 of the Health and Safety Code authorizes the State Water Board to provide funds to the Regional Water Quality Boards for cleanup of UST sites. Chapter 19 of the State Water Board's Administrative Procedures authorizes up to \$200,000 for sites requiring prompt action.


THEREFORE BE IT RESOLVED THAT:

The State Water Board pursuant to Sections 25299.36 and 25299.51 of the Health and Safety Code, authorizes an amount not to exceed \$200,000 from the EAR Account for the North Coast Regional Board to perform prompt corrective action at 4660 Hessel Road in the town of Sebastopol
