**UST: FIELD FRESH FARMS (FORMER ROMA KOOL INC.) – 320 INDUSTRIAL ROAD, WATSONVILLE, SANTA CRUZ COUNTY - CASE REVIEW & PUBLIC NOTICE OF CASE CLOSURE**

The Central Coast Regional Water Quality Control Board (Central Coast Water Board) is the State regulatory agency responsible for the protection of groundwater and surface water quality within the central coast region. As such, we are overseeing the investigation and cleanup of petroleum hydrocarbons released from the underground storage tank (UST) system at the above referenced site. Mr. David Rose is the party responsible for investigation and cleanup of the site. We are notifying the site property owner and other potentially interested parties of the proposed closure of this case. Please provide your comments or concerns regarding closure of this UST case to this office by **November 28 2016**. It is not necessary to respond if you have no comments. Based on the soil investigation and groundwater sampling results, Central Coast Water Board staff believes there is no significant threat to groundwater resources, human health and the environment from this site. Petroleum hydrocarbon concentration trends are nondetect. The contaminant mass has been removed from the site to the maximum extent practicable. Following the public comment period and resolution of any comments, the Executive Officer will issue a case closure letter pursuant to California Underground Storage Tank Regulations.
