On 22 June 2006, the Central Valley Regional Water Quality Control Board (Central Valley Water Board) adopted Order No. R5-2006-0053, *Coalition Group Conditional Waiver of Waste Discharge Requirements for Discharges From Irrigated Lands* (Conditional Waiver) pursuant to Water Code Section 13269 for discharges to surface waters from irrigated lands. On 23 June 2006, the Central Valley Water Board directed that the Conditional Waiver be re-opened to consider revisions to two conditions in Attachment B.

The Central Valley Water Board will consider adoption of a Resolution to revise the Conditional Waiver with respect to submittal of management plans and exceptions to the deadline for adding participants to Coalition Groups. The proposed revision addresses exceptions to the deadline for adding participants to Coalition Groups.

All interested persons may speak at the Central Valley Water Board meeting, and are expected to orally summarize their written comments. Oral testimony will be limited in time by the Central Valley Water Board Chairman.
