FORMER McCLELLAN AIR FORCE BASE
FORMER CAPEHART GAS STATION/SHOPPETTE (BUILDING 5365)
SACRAMENTO COUNTY**

The United States Department of the Air Force, Air Force Real Property Agency formerly the Air Force Base Conversion Agency (hereafter Discharger) owned and operated the former Capehart Gas Station/Shoppette (Building 5365) site located on the northeast corner of Navaho Drive and Aztec Way in Antelope, California.

The Central Valley Regional Water Quality Control Board (Regional Water Board) adopted Cleanup and Abatement Order (CAO) No. R5-2002-0706 on 31 January 2002 directing the investigation, clean up, and abatement, forthwith, of soil and potential groundwater pollution from activities at the former Capehart Gas Station/Shoppette (Building 5365). The Discharger is in compliance with the requirements of CAO No. R5-2002-0706. The Tentative Regional Water Board Order proposes to rescind the existing CAO.

Persons wishing to comment on this noticed hearing item must submit evidence, if any, or comments in writing to the Regional Board no later than noon on **30 November 2007**. Written evidence or comments submitted after noon on **30 November 2007** will not be accepted and will not be incorporated into the administrative record if doing so would prejudice any party.

All interested persons may speak at the Board meeting, and are expected to orally summarize their written submittals. Oral testimony will be limited in time by the Board Chair.

An objection by a party, either in writing or at the time of the hearing, to the decision to hold a hearing not allowing cross-examination and rebuttal testimony by designated parties shall be resolved by the Board Chair before going ahead under the proposed procedures. Failure to make a timely objection to the use of the

proposed hearing procedure before those procedures are used will constitute consent to those procedures.
