RECISSION OF CEASE AND DESIST ORDER NO. R5-2007-0022
AND
REVISED WASTE DISCHARGE REQUIREMENTS
FOR
COUNTY OF SHASTA
REDDING REGIONAL SEPTAGE DISPOSAL FACILITY
SHASTA COUNTY

County of Shasta (Discharger) owns and operates the Redding Regional Septage Disposal Facility, approximately 3.5 miles west of the City of Anderson, to serve the unsewered areas of the county by treating and disposing of septage generated by septic tank systems. In 1994, the facility consisted of ten unlined ponds. In 2007, the Discharger installed five lined ponds to accommodate the increasing septage intake and prevent wastewater overflow. The Discharger has completed the tasks identified in Cease and Desist Order (CDO) No. R5-2007-0022. The Waste Discharge Requirements (WDRs) are being revised to rescind WDR Order No. 94-018 and prescribe requirements for the Facility that conform to current Board plans and policies.

The designated parties for this hearing are as follows:

Only designated parties will have these rights: to call and examine witnesses; to introduce exhibits; to cross-examine opposing witnesses; to impeach any witness; and to rebut the evidence against him or her. All other persons wishing to testify or provide comments are interested persons and not designated parties. Such interested persons may request status as a designated party for purposes of this hearing by submitting such request in writing to the Board no later than **18 August 2008**. The request must explain the basis for status as a designated party and in particular how the person is directly affected by the discharge.

The revised Tentative Waste Discharge Requirements was issued on **18 July 2008**. Persons wishing to comment on this noticed hearing item shall submit testimony, evidence, if any, and/or comments in writing to the Regional Board no later than by noon on **18 August 2008**. Written evidence or comments submitted after noon on **18 August 2008** will not be accepted and will not be incorporated into the administrative record if doing so would prejudice any party.

All designated parties and interested persons may speak at the Regional Board meeting, and are expected to orally summarize their written submittals. Oral testimony and cross examination will be limited in time by the Board Chair
