The City of Woodland (Discharger) owns and operates the City of Woodland Water Pollution Control Facility, a treatment system that provides service to domestic, commercial, and industrial customers within its community. The 10.4 million gallons per day treatment system consists of secondary biological treatment, tertiary filtration, ultraviolet light disinfection, and sludge handling. Treated wastewater is discharged to the Tule Canal and the Yolo Bypass, which flows into the Delta.

A public hearing concerning this matter will be held during the Regional Water Quality Control Board (Regional Water Board) meeting which is scheduled for:

Only designated parties will have these rights: to call and examine witnesses; to introduce exhibits; to cross-examine opposing witnesses; to impeach any witness; and to rebut the evidence against him or her. All other persons wishing to testify or provide comments are interested persons and not designated parties. Such interested persons may request status as a designated party for purposes of this hearing by submitting such request in writing to the Board no later than **10 October 2008**. The request must explain the basis for status as a designated party and in particular how the person is directly affected by the discharge.

The tentative Waste Discharge Requirements were issued on **31 August 2008**. Persons wishing to comment on this noticed hearing item shall submit testimony, evidence, if any, and/or comments in writing to the Regional Water Board no later than 5:00 p.m. on **30 September 2008**. Written evidence or comments submitted after 5:00 p.m. on **30 September 2008** will not be accepted and will not be incorporated into the administrative record if doing so would prejudice any party.

All designated parties and interested persons may speak at the Regional Water Board meeting, and are expected to orally summarize their written submittals. Oral testimony and cross examination will be limited in time by the Board Chair
