WASTEWATER TREATMENT AND LAND DISPOSAL FACILITY
SAN JOAQUIN COUNTY**

The Central Valley Regional Water Quality Control Board (Central Valley Water Board) will consider adoption of an Order rescinding Cease and Desist Order (CDO) No. R5-2007-0139. The Central Valley Water Board adopted CDO No. R5-2007-0139 on 26 October 2007 for the Musco Family Olive Company and The Studley Company (Discharger) in San Joaquin County. The Discharger applies wastewater generated in an olive cannery to land application areas. The CDO required technical studies and submittal of a Report of Waste Discharge (RWD) to allow updating the facility WDRs. The studies and RWD were submitted and a revised Waste Discharge Requirements Order for the facility was adopted by the Central Valley Regional Water Quality Control Board on 18 March 2010.

The designated parties for this hearing are as follows:

- Musco Family Olive Company and The Studley Company

Only designated parties will have these rights: to call and examine witnesses; to introduce exhibits; to cross-examine opposing witnesses; to impeach any witness; and to rebut the evidence against him or her. All other persons wishing to testify or provide comments are interested persons and not designated parties. Such interested persons may request status as a designated party for purposes of this hearing by submitting such request in writing to the Board no later than **21 July 2010**. The request must explain the basis for status as a designated party and in particular how the person is directly affected by the discharge.

The tentative order to rescind Cease and Desist Order No. R5-2007-0139 was issued on 20 May 2010. The deadline for submitting written comments concerning the proposed action was 21 June 2010. Written evidence or comments submitted after noon on 21 June 2010 will not be accepted and will not be incorporated into the administrative record if doing so would prejudice any party.

All designated parties and interested persons may speak at the Regional Board meeting, and are expected to orally summarize their written submittals. Oral testimony and cross examination will be limited in time by the Board Chair.
