**NOTICE OF PUBLIC HEARING**  
concerning

**RENEWAL OF WASTE DISCHARGE REQUIREMENTS  
(NPDES PERMIT NO. CA0082066)  
FOR  
SIERRA PACIFIC INDUSTRIES, INC.  
ANDERSON DIVISION  
SHASTA COUNTY**

Sierra Pacific Industries, Inc. (Discharger) owns and operates the Anderson Division Sawmill and Cogeneration Facility located at 19758 Riverside Avenue near Anderson, Shasta County. The Discharger may be contacted by mail at P.O. 10939, Anderson, CA 96007. The Facility consists of a 150-million board foot sawmill, planer mill, millwork, drying kilns, wood fired cogeneration boiler for generation of electrical power and steam for kiln heating, paved log unloading and scaling yard, rough cut lumber storage area, bark processing and storage area, chip loading area, log deck, pole log deck, fabrication shop, truck shop, paved finished lumber storage areas and separate pole handling facilities which include a scaling yard and log deck.

Cogeneration process water, sawmill process water, and industrial storm water are discharged to a network of onsite storage ponds. If the combined storage capacity of the ponds is projected to be exceeded due to a very high rainfall winter (e.g., annual rainfall greater than 100-year return frequency), then the Discharger discharges subsequent industrial storm water from the southern portion of the Facility to the Sacramento River through Discharge Point D-002. Cogeneration process water, log deck recycle water, log deck storm water, and industrial storm water from the northern portion of the Facility continues to be stored in the ponds, and do not discharge to the river.

The Discharger is in the process of adding a new cogeneration power facility, including a new fuel shed, boiler building, turbine building, cooling tower, electrostatic precipitator, ash silo and electric substation, at the Facility. The boiler would burn biomass fuel to produce steam to dry lumber in existing kilns and to power a steam turbine. The steam turbine would drive a generator that would produce up to 31 MW of electricity.

The Discharger is expected to be able to immediately comply with the tentative NPDES permit, if adopted. This item was previously scheduled to be considered at the Regional Water Board's April and August 2011 Board meetings, but was pulled from the Agenda due to the lack of a voting quorum.

Designated parties but not interested persons will have these rights: to call and examine witnesses; to cross-examine opposing witnesses; to impeach any witness; and to rebut the evidence against him or her. Regional Water Board staff will prepare the administrative record, and may present evidence, make an oral presentation and cross-examine opposing witnesses.

Interested persons may not cross examine witnesses, and will not be subject to cross examination. Interested persons may submit evidence (e.g., photographs, eye-witness testimony, monitoring data) if the evidence is submitted in accordance with the deadlines for submitting evidence described below. Interested persons who present evidence may be subject to cross-examination. No interested persons requested status as a designated party for purposes of this hearing by the previous deadline of 5:00 p.m. on 23 June 2011.

The tentative Order was issued on 24 May 2011 for a 30-day public comment period. No comments were received by the deadline of 5:00 p.m. on 23 June 2011. No new testimony, evidence, and/or comments regarding the tentative Order will be accepted and will not be incorporated into the administrative record absent a ruling by the Chair. A party requesting to submit late materials must demonstrate good cause for the late submission, and the Chair must find that the late submission would not prejudice the Regional Water Board or any designated party.

All designated parties and interested persons may speak at the Regional Water Board meeting, and are expected to orally summarize their written submittals. Oral testimony and cross examination will be limited in time by the Board Chair. Both designated parties and interested persons may be asked to respond to clarifying questions from Regional Water Board members, counsel staff or others, at the discretion of the Regional Water Board.
