CEASE AND DESIST ORDER R5-2005-0033  
FOR  
UNITED AUBURN INDIAN COMMUNITY  
THUNDER VALLEY CASINO  
WASTEWATER TREATMENT PLANT  
PLACER COUNTY

The California Regional Water Quality Control Board, Central Valley Region, (hereafter referred to as "Central Valley Water Board") finds that:

1. The United Auburn Indian Community (Discharger) owns and operates the Thunder Valley Casino (formerly Auburn Rancheria Casino) Wastewater Treatment Plant (WWTP). The Discharger was previously regulated under Waste Discharge Requirements (WDRs) Order R5-2005-0032 (NPDES No. CA0084697). As of 28 January 2010, effective 19 March 2010, the Discharger is regulated by Order R5-2010-0005.
2. On 17 March 2005, the Central Valley Water Board adopted Cease and Desist Order (CDO) R5-2005-0033 for the United Auburn Indian Community. The CDO required full compliance with the effluent limitations for aluminum, ammonia, arsenic, atrazine, boron, electrical conductivity, fluoride, MBAS, nitrate, persistent chlorinated hydrocarbon pesticides, sulfate, and total trihalomethane by 11 March 2008.
3. Effective August 2009, the Discharger has consistently achieved compliance with the effluent limitations in Order R5-2005-0032, as evidenced by self-monitoring reports.
4. The Central Valley Water Board has notified the Discharger and interested agencies and persons of its intent to rescind Order R5-2005-0033 and has provided them with an opportunity for a public hearing and an opportunity for them to submit their written views and recommendations.
5. Issuance of this Order is exempt from the provisions of the California Environmental Quality Act (Public Resources Code section 21000 et seq.), in accordance with California Code of Regulations, title 14, section 15321(a) (2).
6. The Central Valley Water Board, in a public meeting, heard and considered all comments and evidence pertaining to this matter.
