The City of Colusa is the owner and operator of the Colusa Wastewater Treatment Plant (Facility), a publicly owned treatment works located at 2830 Will S. Green Road, Colusa, California. The Facility provides sewerage services for the City of Colusa, serving a population of approximately 6,000. The Facility provides tertiary treatment for up to 0.7 million gallons per day. Tertiary treated wastewater from the Facility is discharged to the unnamed tributary to Powell Slough, tributary to the Sacramento River, both are waters of the United States.

Discharges from the Facility are regulated by Waste Discharge Requirements Order R5-2016-0062, adopted by the Central Valley Regional Water Quality Control Board (Central Valley Water Board) at the 18 August 2016 Board Meeting. The Discharger has demonstrated that additional time is needed to comply with the final effluent limitations for copper prescribed in Order R5-2016-0062. Therefore, a Time Schedule Order is proposed allowing an extension of the time schedule for compliance with these final effluent limitations until 30 June 2020.

The designated parties for this hearing are as follows:

Only designated parties will have these rights: to call and examine witnesses; to introduce exhibits; to cross-examine opposing witnesses; to impeach any witness; and to rebut the evidence against him or her. All other persons wishing to testify or provide comments are interested persons and not designated parties. Such interested persons may request status as a designated party for purposes of this hearing by submitting such request in writing to the Central Valley Water Board no later than **5:00 p.m. on 26 September 2016**. The request must explain the basis for status as a designated party and in particular how the person is directly affected by the discharge. Persons wishing to comment on this noticed hearing item shall submit testimony, evidence, if any, and/or comments in writing to the Central Valley Water Board, or via email to **RB5S-NPDES-Comments@waterboards.ca.gov** no later than **5:00 p.m. on 26 September 2016**. Written evidence or comments submitted after **5:00 p.m. on 26 September 2016** will not be accepted and will not be incorporated into the administrative record absent a ruling by the Board Chair. Any party requesting to submit

late materials must demonstrate good cause for the late submission, and the Board Chair must find that accepting the late submission will not prejudice the Central Valley Water Board or any Designated Party.


