TENTATIVE ORDER OF REVISED WASTE DISCHARGE REQUIREMENTS AND WATER RECLAMATION REQUIREMENTS, AND MONITORING AND REPORTING PROGRAM FOR THE LIMONEIRA COMPANY – LIMONEIRA WASTEWATER TREATMENT PLANT AT 1141 CUMMINGS ROAD SANTA PAULA, CALIFORNIA (ORDER NO. 2024-XXXX, FILE NO. 66-066, CI-5322, GEOTRACKER GLOBAL ID WDR100017186)

The Los Angeles Regional Water Quality Control Board (Los Angeles Water Board) will hold a public meeting to consider a tentative revised Waste Discharge Requirements (WDRs) and Water Reclamation Requirements (WRRs) Order No. R4-2014-0040, which was adopted on April 15, 2014, for the discharge of disinfected treated domestic and non-domestic wastewater from the Limoneira Wastewater Treatment Plant.
