Central Valley Water Board Issues Notices of Violation to East San Joaquin Valley Growers for Failing to Submit Nitrogen Management Plan Summary Reports

The Central Valley Water Board has issued 67 Notices of Violation to East San Joaquin Water Quality Coalition members for failure to submit Nitrogen Management Plan Summary Reports. These reports are important because they identify potential risks to groundwater from nitrogen.

In 2012, the Central Valley Water Board issued waste discharge requirements (WDRs) that allowed farmers in the East San Joaquin River Watershed to join the East San Joaquin Water Quality Coalition. The WDRs require that each Coalition member prepare and implement a farm-specific Nitrogen Management Plan (NMP). On the NMP, Coalition members account for projected nitrogen needs and application rates for the upcoming crop year. Actual nitrogen applications are recorded in the NMP at the end of the season. The following March, members submit NMP Summary Reports to the Coalition, which provide crop data, yield, and total nitrogen applied for the previous crop year.

"The Nitrogen Management Plan Summary Reports are critical to the Board's efforts to address nitrate contamination in groundwater. If the NMPs and Summary Reports are ineffective because of poor Coalition member reporting, the Board may have to resort to a more expensive and intrusive option: issuing individual permits to growers and requiring farm-specific downgradient groundwater monitoring to demonstrate compliance with water quality objectives," said Andrew Altevogt, Assistant Executive Officer for the Central Valley Water Board.

The NMP Summary Reports provide the Central Valley Water Board with information regarding individual member's compliance with the WDRs' requirements. Without this information, the Board cannot proactively assess potential risks to groundwater from nitrogen applications and take measures to address these risks. Groundwater monitoring alone will not provide a real-time indication as to whether members are managing nitrogen to protect groundwater. Improved nitrogen management may take place relatively quickly, although it may take many years before broad trends in nitrate reduction in groundwater may be measured. Nitrogen

management reporting will identify Coalition members who may not be adequately managing nitrogen applications while trend data are collected.

The Notices of Violation require that the NMP Summary Reports be submitted to the Coalition and the Central Valley Water Board. The addition of direct reporting to the Central Valley Water Board ensures that this critical information can be used to protect water quality.
