NOTICE OF OPPORTUNITY TO COMMENT

PROPOSED APPROVAL OF AN AMENDMENT TO THE WATER QUALITY CONTROL PLAN FOR THE COLORADO RIVER BASIN REGION TO PROHIBIT THE DISCHARGE OF WASTEWATER INTO THE GROUND FROM SEPTIC SYSTEMS IN THE TOWN OF YUCCA VALLEY IN SAN BERNARDINO COUNTY

NOTICE IS HEREBY GIVEN THAT the State Water Resources Control Board (State Water Board) will accept comments on the Colorado River Basin Regional Water Board's (Colorado River Basin Water Board's) amendment to the Water Quality Control Plan for the Colorado River Basin Region that would prohibit the discharge of wastewater into the ground from septic systems in the Town of Yucca Valley in San Bernardino County (Basin Plan amendment). - 1. Comments must specifically address the version of the Basin Plan amendment that was adopted by the Colorado River Basin Water Board.
- 2. If the Colorado River Basin Water Board previously responded to a similar or identical comment, the commenter must explain why and in what manner the commenter believes each of the responses provided by the Colorado River Basin Water Board to each comment was inadequate or incorrect.
- The commenter also must include either a statement that each of the comments was timely raised before the Colorado River Basin Water Board, or an explanation of why the commenter was unable to raise the specific comment before the Colorado River Basin Water Board.
