Issuance of Revised Waste Discharge Requirements

SAN JOAQUIN COUNTY**

The State Department of Corrections and Rehabilitation (Discharger) has requested a change in the due date of the *Groundwater Monitoring Installation Report* required in Waste Discharge Requirements Order No. R5-2006-0075. This change will not affect the protection of water quality and these revised waste discharge requirements still require that background concentrations and water quality protection standards be established before waste is placed in the Class II surface impoundments. The Discharger plans to construct a reverse osmosis groundwater treatment plant. The wastewater generated from the reverse osmosis plant will be reduced in a brine concentrator and discharged to four lined evaporation basins. Approximately 5,600 gallons per day of wastewater will be discharged to the evaporation basins. The revised Waste Discharge Requirements will prescribe operation and monitoring requirements for the evaporation basins in accordance with California Code of Regulations, Title 27, Division 2.

The designated parties for this hearing are as follows:

- California Department of Corrections and Rehabilitation

Only designated parties will have these rights: to call and examine witnesses; to introduce exhibits; to cross-examine opposing witnesses; to impeach any witness; and to rebut the evidence against him or her. All other persons wishing to testify or provide comments are interested persons and not designated parties. Such interested persons may request status as a designated party for purposes of this hearing by submitting

such request in writing to the Board no later than **22 December 2006**. The request must explain the basis for status as a designated party and in particular how the person is directly affected by the discharge.

Persons wishing to comment on this noticed hearing item must submit testimony, evidence, if any, and/or comments in writing to the Regional Board no later than **22 December 2006**. Written evidence or comments submitted after **22 December 2006** will not be accepted and will not be incorporated into the administrative record if doing so would prejudice any party.

All designated parties and interested persons may speak at the Regional Board meeting, and are expected to orally summarize their written submittals. Oral testimony and cross examination will be limited in time by the Board Chair.
