SACRAMENTO COUNTY**

The County of Sacramento, Department of Waste Management and Recycling (Discharger) is the owner and operator of the Kiefer Landfill Groundwater Extraction and Treatment Plant (Facility), a groundwater extraction and treatment plant within a municipal solid waste landfill. The groundwater extraction and treatment system consists of a groundwater extraction well network and an air stripping system, and was established as a means of controlling contaminant migration and removing volatile organic compounds from groundwater. The design flow capacity of the Facility is 2.17 million gallons per day (MGD). Treated groundwater is discharged to Deer Creek, a water of the United States, tributary to the Cosumnes River.

Discharges from the Facility are currently regulated by Waste Discharge Requirements Order R5-2007-0014-01 (NPDES Permit), issued by the Central Valley Regional Water Quality Control Board (Central Valley Water Board) on 15 May 2007 and amended on 2 August 2012.

A tentative Order for the proposed NPDES Permit renewal was issued for public review and comment on 11 May 2012 and the 30-day comment period ended on 15 June 2012.

The designated parties for this hearing are as follows:

Only designated parties will have these rights: to call and examine witnesses; to introduce exhibits; to cross-examine opposing witnesses; to impeach any witness; and to rebut the evidence against him or her. All other persons wishing to testify or provide comments are interested persons and not designated parties. Such interested persons may request status as a designated party for purposes of this hearing by submitting such request in writing to the Central Valley Water Board no later than **5:00 p.m. on 28 December 2012**. The request must

explain the basis for status as a designated party and in particular how the person is directly affected by the discharge.

A tentative Order was issued for public review and comment on 11 May 2012, and the 30-day comment period ended on 15 June 2012. Written evidence or comments submitted after **15 June 2012** will not be accepted and will not be incorporated into the administrative record if doing so would prejudice any party.

All designated parties and interested persons may speak at the Central Valley Water Board meeting, and are expected to orally summarize their written submittals. Oral testimony and cross examination will be limited in time by the Board Chair.
