**TENTATIVE ADDENDUM NO. 2 TO ORDER NO. 94-039**

**AN ADDENDUM TRANSFERRING RESPONSIBILITY FOR ORDER NO. 94-039**

**FROM MR. LARRY A. READ  
TO OAK VILLAGE INC., OAK KNOLL CAMPGROUND, SAN DIEGO COUNTY**

The California Regional Water Quality Control Board, San Diego Region (hereinafter Regional Board), finds that:

1. On May 12, 1994, the Regional Board adopted Order No. 94-039, *Waste Discharge Requirements for Mr. Elmer Anderson, Lilac Oaks Campground, San Diego County*. Order No. 94-039 prescribes waste discharge requirements for the discharge of domestic wastewater at Oak Knoll Campground via septic tanks and a subsurface leach field system.
2. On August 14, 2002, the Regional Board adopted Tentative Addendum No. 1 to Order No. 94-039 which transferred responsibility for Order No. 94-039 from Mr. Elmer Anderson to Mr. Larry A. Read.
3. The Regional Board was notified on October 14, 2009 that the transfer of ownership of Oak Knoll Campground from Mr. Larry A. Read to Oak Village Inc. occurred on August 25, 2008.
4. This Order, which enforces the laws and regulations administered by the Regional Board, involves the permitting of an existing facility and does not involve expansion beyond that existing at the time of adoption of this Order. This Order therefore is categorically exempt from the California Environmental Quality Act (CEQA) (Public Resources Code section 21000, *et seq.*) pursuant to California Code of Regulations, Title 14, Chapter 3, Article 19, section 15301.
5. The Regional Board has notified all known interested persons of its intent to modify Order No. 94-039 to reflect the transfer of responsibility.
6. The Regional Board, in a public hearing, heard and considered all comments pertaining to the modification of Order No. 94-039.

IT IS HEREBY ORDERED, THAT:

1. Order No. 94-039 shall henceforth be titled *Waste Discharge Requirements for Oak Village Inc., Oak Knoll Campground, San Diego County*.
2. The waste discharge requirements contained in Order No. 94-039 shall be the responsibility of Oak Village Inc.

3. The "Discharger", as it appears in Order No. 94-039, shall hereinafter refer to Oak Village Inc.
4. Mr Larry A. Read is liable for violations of Order No. 94-039 prior to the ownership transfer date and Oak Village Inc. is liable for violations of Order No. 94-039 from the ownership transfer date forward.
