TENTATIVE ADDENDUM NO. 1 TO ORDER NO. 94-074

AN ADDENDUM TRANSFERRING RESPONSIBILITY FOR ORDER NO. 94-074

**FROM MILO AND JOAN CROUSE
TO MR. LARRY TARDIE, LILAC OAKS CAMPGROUND, SAN DIEGO COUNTY**

The California Regional Water Quality Control Board, San Diego Region (hereinafter Regional Board), finds that:

1. On June 9, 1994, the Regional Board adopted Order No. 94-074, *Waste Discharge Requirements for Milo and Joan Crouse, Lilac Oaks Campground, San Diego County*. Order No. 94-074 prescribes waste discharge requirements for the discharge of domestic wastewater at Lilac Oaks Campground via septic tanks and a subsurface leach field system.
2. The Regional Board was notified on October 12, 2009 that the transfer of ownership of Lilac Oaks Campground from Milo and Joan Crouse to Mr. Larry Tardie occurred on November 10, 2007.
3. This Order, which enforces the laws and regulations administered by the Regional Board, involves the permitting of an existing facility and does not involve expansion beyond that existing at the time of adoption of this Order. This Order therefore is categorically exempt from the California Environmental Quality Act (CEQA) (Public Resources Code section 21000, *et seq.*) pursuant to California Code of Regulations, Title 14, Chapter 3, Article 19, section 15301.
4. The Regional Board has notified all known interested persons of its intent to modify Order No. 94-074 to reflect the transfer of responsibility.
5. The Regional Board, in a public hearing, heard and considered all comments pertaining to the modification of Order No. 94-074.

IT IS HEREBY ORDERED, THAT:

1. Order No. 94-074 shall henceforth be titled *Waste Discharge Requirements for Mr. Larry Tardie, Lilac Oaks Campground, San Diego County*.
2. The waste discharge requirements contained in Order No. 94-074 shall be the responsibility of Mr. Larry Tardie.
3. The "Discharger", as it appears in Order No. 94-074, shall hereinafter refer to Mr. Larry Tardie.

4. Milo and Joan Crouse are liable for violations of Order No. 94-074 prior to the ownership transfer date and Mr. Larry Tardie is liable for violations of Order No. 94-074 from the ownership transfer date forward.
