

Subject: Notice of Public Hearing and Written Comment Period for Tentative Order No. R9-2015-0012, Waste Discharge Requirements for the United States Navy Remote Training Site Onsite Wastewater Treatment System, Warner Springs

Mr. Gordon:

This serves to inform you that the California Regional Water Quality Control Board San Diego Region (San Diego Water Board) will consider adoption of Tentative Order No. R9-2015-0012, *Waste Discharge Requirements for the United States Navy Remote Training Site Onsite Wastewater Treatment System, Warner Springs* (Tentative Order), at its scheduled meeting on Wednesday, February 11, 2015. The Tentative Order, if adopted, will prescribe waste discharge requirements for the discharge of secondary treated domestic wastewater from the United States Navy Remote Training Site Onsite Wastewater Treatment System. The Remote Training Site is located near Warner Springs.


