NOTICE OF CANCELLATION OF PUBLIC HEARING AND PRE-HEARING CONFERENCE

The Notice of Proposed Revocation was
issued by the State Water Resources Control Board,
Office of the Delta Watermaster.

TO ALL PARTIES:

On March 24, 2022, Michael Patrick George, the Delta Watermaster for the State Water Resources Control Board (State Water Board), issued a Notice of Proposed Revocation of water-right License 881B (Notice of Proposed Revocation) pursuant to Water Code sections 1675 and 1241. On April 8, 2022, Assistant District Counsel for the Sacramento District of the United States Army Corps of Engineers (USACE) sent a letter to the Delta Watermaster requesting a hearing on the Notice of Proposed Revocation.

On July 5, 2022, the Administrative Hearings Office (AHO) issued a Notice of Public Hearing and Pre-Hearing Conference in this matter, which scheduled a pre-hearing conference on July 26, 2022, and a hearing on December 15, 2022.

On July 21, 2022, the Delta Watermaster sent a letter to USACE stating that he was withdrawing the Notice of Proposed Revocation of water-right License 881B and that he would request that the AHO cancel the hearing in this matter. Also on July 21, 2022, John Prager, an attorney with the State Water Resources Control Board's Office of Enforcement, sent an e-mail to the AHO with a copy of the Delta Watermaster's July 21 letter to USACE. The e-mail requested that the AHO cancel the hearing scheduled in this matter.

Based on the Delta Watermaster's withdrawal of the Notice of Proposed Revocation, the AHO **cancel**s the pre-hearing conference and public hearing that were scheduled in this matter, on July 26 and December 15, 2022, respectively.
