Hi Michael,

Thank you for submitting LADWP Haynes Generating Station's flow and impingement data for the October 2017-September 2018 operating period (17-18 Operating Period). I'm reaching out with a follow-up question about the intake volumes in the table in Enclosure 1. When comparing the flow data in million gallons per day (MGD) from LADWP's December 21, 2018 letter with the flow data submitted to CIWQS, I noticed that the sums of Outfall 2A&2B for the 17-18 Operating Period did not match (please see attachment):

- December 21, 2018 letter Outfall 2A&2B for 10/1/2017 to 9/30/2018: 83,619 MGD
- CIWQS Outfall 2A&2B for 10/1/2017 to 9/30/2018: 76,484 MGD

Therefore, the total flow for the 17-18 Operating Period based off of CIWQS data is 164,413 MGD instead of 171,543 MGD. It looks like flows from an extra month might have gotten added into the total included in the letter. Please resubmit to me **via email** Enclosure 1 with the December 2017 data included by close of business on Friday, February 28. Resubmission via hard copy is not required.
