#### Reporting Enrollee-Owned/Operated Non-Category 1 Lateral Spills in the CIWQS Sanitary Sewer System Database

Per Attachment E1, Section 3.7. of <u>General Order 2022-0103-DWQ</u>, if Enrollee-owned and/or operated lateral spills (that did not discharge to a surface water) occur during a calendar month, the Enrollee shall certify, within 30 calendar days after the end of the calendar month, a "Non-Category 1 Lateral Spills" certification statement in the online CIWQS Sanitary Sewer System Database (<u>https://ciwqs.waterboards.ca.gov</u>),.

Per Attachment E1, Section 4.4. of the Order, the Enrollee must maintain records of all non-Category 1 Enrollee-owned and/or operated lateral spills that are caused by a failure or blockage in the lateral. The enrollee must upload and certify a report into the CIWQS Sanitary Sewer System Database (https://ciwqs.waterboards.ca.gov) by February 1<sup>st</sup> after the end of calendar year in which the spills occurred (Attachment E1, Section 3.6).

It should be noted that a spill from an Enrollee-owned and/or operated lateral that does discharge to surface water would be considered a Category 1 Spill and should be reported as a Category 1 spill.

Attachment E2, Table E2-5 of the Order provides a summary of the notification, monitoring, and reporting requirements for Enrollee-owned and/or operated lateral spills that do not discharge to surface water. Below is a snapshot of Table E2-5 for your convenience.

In summary, the Order requires the following key points for Enrollee-owned/operated lateral spills that do not discharge to a surface water:

1- Certify a "Non-Category 1 Lateral Spills" statement in the online CIWQS Sanitary Sewer System Database if Enrollee-owned and/or operated lateral spills (that do not discharge to a surface water) occur during a calendar month;

Due within 30 calendar days after the end of that month.

2- Upload and certify a report of lateral spills (that do not discharge to a surface water) to the online CIWQS Sanitary Sewer System Database;

Due by February 1<sup>st</sup> after the end of the calendar year in which the spills occurred.

#### Annual Reporting of all Enrollee-Owned/Operated Lateral Spills

There are two methods by which the Enrollee may report their annual owned or operated lateral spills (that do not discharge to a surface water) to the online CIWQS Sanitary Sewer System Database;

1 - Report the details of each individual Enrollee-owned/operated lateral spill individually using a report form.

2 - Upload the Enrollee-owned/operated Lateral Spill Report Reporting Spreadsheet containing multiple records of the respective spills using a spreadsheet <sup>t</sup>.

**NOTE:** The details of Enrollee-Owned/Operated Lateral Spills can be reported throughout the year or all at once. Regardless of which method is used, the Enrollee shall still:

- Certify monthly if Enrollee-Owned/Operated Lateral Spills occurred
- Certify the details of each spill by February 1<sup>st</sup> of the following year.

#### How to Report Individual Enrollee-Owned/Operated Lateral Spills

1- Follow steps 1 to 3 above to log into the CIWQS Sanitary Sewer Systems database:

3- Click on the "Report an Individual Spill" link:



**NOTE**: Annual reporting is not required if the Sanitary Sewer System did not have any Enrollee Owned/Operated lateral spills during the reporting year.
