NOTICE IS HEREBY GIVEN THAT the State Water Resources Control Board (State Water Board) will accept comments on the proposed underground storage tank (UST) case closure for UST case number 1THU052, Tipple Motors, 524 Main Street, Ferndale, California.

Enclosed is a draft UST case closure summary prepared by State Water Board staff for the above-entitled matter. Pursuant to Health and Safety Code Section 25296.40, the State Water Board will be considering, at a future board meeting, whether this UST case should be closed. All comments shall be based solely upon evidence contained in the record or upon legal argument. Supplemental evidence will not be permitted except under the limited circumstances described in California Code of Regulations, Title 23, Section 2814.8.
