NOTICE OF PETITIONS FOR CHANGE OF PLACE OF USE AND PURPOSE OF USE TO DEDICATE WATER FOR THE PRESERVATION AND ENHANCEMENT OF FISH AND WILDLIFE RESOURCES FOR SHASTA RIVER DECREE NO. 7035 DIVERSION NUMBERS 167, 168, 169, 170, 171, 172, 241, 243, 244, 245, 246, 247, 248 (ADJUDICATED WATER RIGHTS J000014, J000015, J000016, J000017, J000018, J000019, J000020, J000021)

COUNTY: Siskiyou STREAM SYSTEM: Hole in the Ground Creek

Little Springs Creek Big Springs Creek Shasta River

The Nature Conservancy has filed petitions for change for Shasta River Decree 7035 diversion numbers 167, 168, 169, 170, 171, 172, 241, 243, 244, 245, 246, 247, 248. Any correspondence directed to the Petitioner should be mailed to:

The State Water Resources Control Board (State Water Board) will determine whether to approve the petitions and whether such changes should be conditioned to protect other legal users of water, the public interest, or the environment. If the State Water Board approves the petitions, either the State Water Board or The Nature Conservancy may initiate the procedures in the Siskiyou County Superior Court to amend the Shasta River Decree to reflect the approved changes. If approved, the State Water Board may file a Notice of Exemption for the petitions pursuant to the California Environmental Quality Act for minor alterations to land, water or vegetation, environmental and natural resources protection projects, and small habitat restoration projects. (Cal. Code Regs., §§ 15304, 15307, 15308, 15333.)

In general, The Nature Conservancy proposes to forego diversion under some or all of the above-listed water rights during certain water years, as determined in coordination with the Department of Fish and Game and the Watermaster. The portion of such water that would otherwise have been consumptively used would be protected downstream from the point of diversion to the United States Geological Survey gage on the Shasta River. The instream dedication should not result in any change to water availability to downstream users from a situation where the water was applied to pasture. Petitioners anticipate that in most years, the water would continue to be applied to irrigate pasturelands. A summary of the changes for each individual water right follows.
