Dear Kathleen,

In response to your concerns about the use of water for the above referenced petition, I realize I made a mistake in the application. I did not intend to limit the license to 130 acre feet per year. The intention of Cal-Cel Marketing, Inc. is to change the place of use to irrigate 55 acres of farmland, which requires approximately 385 acre feet per year water duty. Below, please find a breakdown for the crop water duty.
