U.S. Bureau of Reclamation, attn: Bob Colella, 2800 Cottage Way, Sacramento, CA 95825-1898, filed petitions for Temporary Transfer of Water and Change pursuant to Water Code sections 1725 and 1707 to benefit fish and wildlife resources downstream of Millerton Reservoir (Friant Dam).
