Dear Hearing Officers Doduc and Marcus:

On September 22, 2016, the Chair graciously granted the City of Brentwood's request to be able to conduct cross-examination of the Petitioners' Water Rights panel of witnesses out of order due to the need for me to attend a court hearing in Southern California on an unrelated matter this past Friday.

This morning, I discussed the cross-examination of Petitioners' Water Rights panel of witnesses on Friday with my colleague Meredith Nikkel. Based on that discussion, it appears that the lines of cross-examination that Ms. Nikkel and Jennifer Spaletta pursued this past Friday anticipated the lines of cross examination that I would have pursued on behalf of the City of Brentwood regarding whether or not the operation of the WaterFix project would cause injury to in-Delta water right holders. In an effort to avoid duplication of cross-examination, therefore, the City of Brentwood hereby waives any further cross-examination of Petitioners' Water Rights panel of witnesses during Petitioners' case-in-chief. Of course, the City does not hereby waive any rights to cross-examine these same witnesses should Petitioners call them for rebuttal testimony or for testimony during Part 2.
