
RE: California WaterFix Hearing – Sur-Rebuttal Testimony Scheduling Request

Dear Hearing Officers and Board Hearing Staff:

I am writing on behalf of our clients, protestants County of San Joaquin, San Joaquin County Flood Control and Water Conservation District, and Mokelumne River Water and Power Authority (the “San Joaquin County Protestants”), as well as for the Local Agencies of the North Delta, et al. (“LAND”). LAND is separately represented by Osha Meserve.

The San Joaquin County Protestants and LAND have submitted, as a single panel, the sur-rebuttal testimony of witness Dr. Michael T. Brett (SJC-200). We understand that sur-rebuttal presentations will proceed in the order already established in Part 1. LAND is Group 19, and the San Joaquin County Protestants are Group 24. The purpose of this letter to let you know that it is our intention to present this Panel’s sur-rebuttal testimony (that of Dr. Brett) in the San Joaquin County Protestants’ No. 24 spot, subject to any alternative scheduling arrangements we may have to make with other protestant groups consistent with the prior rulings and practices in this proceeding.


