Re: Sacramento Valley Water Users' Subpoenas Duces Tecum

Dear Hearing Chair Doduc, Hearing Officer Marcus, and California WaterFix Hearing Staff:

On June 29, 2017, the Sacramento Valley Water Users ("SVWU") served subpoenas *duces tecum* requesting the U.S. Bureau of Reclamation and California Department of Water Resources ("DWR") to produce documents and modeling files referenced in the Biological Opinions ("BiOps") issued by the United States Fish & Wildlife Service ("USFWS") and the National Marine Fisheries Agency ("NMFS") on June 26, 2017. The subpoenas *duces tecum* required production of the requested documents by 5pm today, July 7, 2017. In advance of this deadline, I met and conferred with counsel for DWR and Reclamation and reached a mutual agreement to modify the schedule for compliance with the subpoenas.

Pursuant to that mutual agreement, the subpoenas are modified per the following terms:

- 1. DWR will produce all of the requested documents and information, including documents and information duplicative of that in Reclamation's possession that Reclamation does not object to being produced.
- 2. The deadline for Reclamation to respond or object to the subpoena will be extended to July 21, 2017 at noon, except that Reclamation reserves all rights and immunities available to it under federal law.
- 3. DWR will make a good faith effort to produce the BiOp Resolution Log component of category (b) and all documents responsive to categories (d) and (i) by July 7, 2017 at 5pm and the deadline for producing those documents will be July 10, 2017 at noon.

- 4. DWR will produce all remaining documents and information by noon on July 17, 2017.
- 5. All documents and information will be produced to the FTP site made available by the CWF Hearing Team.
- 6. The deadline for DWR to object to the subpoena will be extended to noon on July 18, 2017.

The parties appreciate the Hearing Team's cooperation in making the FTP site available to facilitate DWR and Reclamation's compliance with the subpoenas.
