Subject: Request to Upload CWF Part 2 Submittal to FTP Site

Dear Hearing Officers Doduc and Marcus:

The Environmental Justice Coalition for Water (EJCW) experienced technical difficulties in attempting to upload our submittal on November 30, 2017, and respectfully requests the opportunity to upload to the FTP site for the California WaterFix proceeding, as soon as possible, the following three related parts:

- 1) the documents that, due to technical difficulties, failed to upload properly before the November 30, 2017, noon deadline, and for which more detail is provided below;
- 2) one witness exhibit which was inadvertently not included in EJCW's Exhibit List, although it was in hand and, as with the others, we attempted, unsuccessfully, to upload it before noon; and, lastly, 3) a witness exhibit for which a hold was placed in EJCW's Exhibit List (see EJCW-16 of Statement of Service, dated November 30, 2017, attached hereto) and which document EJCW received from the witness to whose testimony it pertains after the noon deadline in the hope of being able to add it later.

We also were alerted by one of our witnesses to the fact that one exhibit pertaining to that same witness's testimony was mislabeled as EJCW-17, now correctly labeled as EJCW-18 in the list below. Combined with the exhibit that was inadvertently left off of EJCW's Exhibit List, but, as above, was in our possession and which we attempted, unsuccessfully, to upload to the FTP site, the exhibit numbers

As may be evident from the Exhibit List, above, the testimony that failed to upload, yesterday, despite our pre-noon efforts, and which we now seek the opportunity to upload represents the entirety of EJCW's direct witness testimony.

The Environmental Justice Coalition for Water had all WaterFix, Part 2, exhibits ready, except for the one exhibit, described above, for which a hold was placed in the Exhibit List. EJCW staff attempted to upload the documents in our possession to the FTP folder assigned to EJCW at approximately 11:55 a.m. Upon checking the progress those documents were making with only a few minutes to go before noon, some of the documents appeared to EJCW's operations manager to have successfully uploaded, while the other documents were still in the process of uploading, but no "red flags" had been raised yet. EJCW's operations manager circulated the attached Statement of Service, then-believing the process of uploading the exhibits to the FTP site to have been successful. Only after e-mailing the Statement of Service at 11:59 a.m. on November 30, 2017, did EJCW's operations manager turn attention back to the FTP site, at which time an ominous error message had appeared in place of what had previously appeared to be some affirmation of completion and otherwise steady progress towards uploading the documents. EJCW's operations manager then attempted to re-upload the documents for which an error message had appeared, only to meet with the same error message. A short while after noon, perhaps as late as 12:10 p.m., the FTP rejected all further attempts to upload any documents.

EJCW's operations manager then called and e-mailed the California WaterFix hearing team, who responded in the early afternoon, after a few e-mail exchanges, that the matter would have to be resolved by way of a request addressed to the hearing officers and circulated to the service list. Hence, this request for your permission to upload these documents now. If granted leave to upload the exhibits, EJCW would promptly do so and send a new notice of availability and statement of service.

With apologies to the hearing officers, hearing team, all parties to the proceeding, and my own staff, seeking to upload documents at, literally, the 11th hour, is not the way I like to operate. I take full responsibility for subjecting my staff to a set of circumstances where time was too short to resolve any technical glitches, which, unfortunately, we encountered. In the future, my staff and I will make every effort to make sure we allow ample time, so that scenario does not repeat itself. In the meantime, we request that we be able to upload the testimony our witnesses and we worked so hard to prepare.
