

PARTIAL ASSIGNMENT OF CONTRACT AND CONSENT THERETO

THIS ASSIGNMENT is entered into by and between the MASON LOUNDY TRUST, WALTER GOODMAN, and MICHAEL BLOCK, Co-Trustees, and the DEPARTMENT OF FISH AND GAME, WILDLIFE CONSERVATION BOARD.

Recitals

1. The Mason Loundy Trust and the United States of America are parties to a contract which, among other things, entitles the Mason Loundy Trust to water. Said contract bears the number 14-06-200-7859A.

2. Currently, the Mason Loundy Trust is entitled to 5,200 acres of supplemental water and 2,653 acres of riparian (Schedule 2) water.

3. The Mason Loundy Trust has entered into a contract with the Department of Fish and Game, Wildlife Conservation Board, pursuant to which it is to transfer to said department all of its right, title, and interest in and to 1,373.23 acres of real property situated in the County of Fresno, State of California.

4. The Mason Loundy Trust desires to assign to the Department of Fish and Game, Wildlife Conservation Board, water to which the Mason Loundy Trust is entitled pursuant to the above-referenced Contract No. 14-06-200-7859A.

5. The Department of Fish and Game, Wildlife Conservation Board, desires to acquire that water.

IT IS NOW THEREFORE AGREED AS FOLLOWS:

Partial Assignment


The Mason Loundy Trust hereby assigns to the Department of Fish and Game, Wildlife Conservation Board, a portion of its right, title and interest in and to a contract between the United States of America and Mason A. Loundy Trust, No. 14-06-200-7859A.

Assignment shall entitle the Department of Fish and Game to 3,120 acres of project water and to 1,321 acres of riparian (Schedule 2) water.


Consent to Partial Assignment of Contract
