
Folsom's has historic water rights dating back to an 1851 filing by Natoma Water Company.

Notice
Notice is hereby given that a company has been formed under the name of the Natoma Water Company for the purpose of taking water by means of a canal from the South Fork of the American River at or near the Rapid known as Salmon Falls and carrying it thence on the southerly side of said South Fork down to the place in the vicinity of Norman Slough and thence in lateral course to the place in the vicinity of the Norman Slough (Whod's Digging) Millon Springs Negro Run Texas Well Alder Springs & Mississippi Run and such other places and on known places as may lie within the reach of said lateral channel or any of them. The said company intend to commence said work forthwith and to have the same completed as soon as practicable they intend to lease their water for the purpose of Flax Washing Quartz Mining Irrigation of tillable lands and for such other useful purposes as they may be desired. They intend to take as much water from the South Fork as may be necessary at all times to fill a canal eight feet wide and four feet deep with a current running ten miles per hour.

Appearances at Hearing Conducted at Sacramento commencing on November 27, 1956, by Henry Holsinger, Chairman, John B. Evans, Member, and W. P. Rowe, Member, State Water Rights Board:

The point or points of diversion under each of those applications is Folsom Dam and/or Nimbus Dam to which right of access has not been acquired by the applicants. Accordingly, issuance of permits to those applicants would be meaningless in view of the obvious necessity of contracting with the United States for a supply of water from the Federal facilities. The service areas which those applicants desire to supply may be supplied equally well and with less administrative confusion by contract with the United States. Permits are being issued to the United States to appropriate enough American River water to adequately supply the applicants naturally dependent on that source and availability of water to such applicants is reasonably assured by the terms to be contained in the permits to be issued to the United States restricting exportation of water under those permits insofar as exportation interferes with fulfillment of needs within Placer, Sacramento and San Joaquin Counties. Other applicants in more remote areas must if necessary seek water from other sources.


Applications 13370, 13371, 13372, and 14662, by the United States, are eligible for approval provided that permits issued pursuant to those applications include terms restricting diversions thereunder to periods extending from about November 1 of each year to about August 1 of the next, provided that rights acquired thereunder remain subject to reduction by appropriation of water for reasonable, beneficial use within the watershed above Folsom Reservoir, provided that releases past Nimbus Dam are sufficient at all times to satisfy demands under downstream rights and requirements for fish conservation and salinity control, provided that deliveries outside of Placer, Sacramento, and San Joaquin Counties are sufficiently restricted to ensure the satisfaction of such demands as developed within those counties, provided such development is undertaken within a reasonable period, and provided that licenses when issued shall be issued to the public agencies of the State within which the water is found to have been put to beneficial use.*


Legend

Location Map





American River Watershed Map



The low water season mentioned in the complaint during which plaintiff is alleged to take all of the natural flow of the American River does not extend through the months of June or November, but does extend through the months of August, September and October of the average years.

*** Conclusions of Law. ***

1.

The defendants are entitled to, and have, a prior appropriation of three thousand inches of the waters of the North Fork of the American River, measured under a four-inch pressure, taken immediately below the first waste gate below their dam, for sale, rental and distribution for agricultural, mining and mechanical purposes at all seasons of each year.

2.

That plaintiff is not entitled to recover any damages from the defendants.

3.

Plaintiff is not entitled to the injunction prayed for in its complaint.

Let judgment be entered accordingly.

San Juan Water District has some of the oldest rights on the North Fork of the American River, dating back to an 1853 notice of appropriation, and confirmed by an 1898 court judgment.

San Juan's 1954 Settlement Agreement with the United States

“Subject to the provisions of this contract, no interest in the water rights possessed by the Contractor shall be considered to have been transferred to the Government hereunder, and no storage space in Folsom Reservoir shall be considered as being involved in this contract, except to the minimum extent in each instance necessary to enable the Government to comply with the terms thereof and to provide at the times and in the quantity specified herein the water to be received by the Contractor and to which it is recognized the Contractor is entitled. . . .”
