Dear Hearing Officers Doduc and Marcus:

Petitioners California Department of Water Resources (DWR) and the United States Department of the Interior, Bureau of Reclamation (Reclamation), request to present their Part 2 case in chief in the form of witness panels, similar to the presentation of Part 1. DWR has set forth the panels in its Revised Supplemental Notice of Intent (Revised NOI) filed on November 28, 2017. However, DWR's Revised NOI panel list did not include Reclamation's expert staff witnesses for Part 2, of which there are only two: Kristin White and Nancy Parker.

Kristin White will sit on Panel One. While Reclamation originally estimated her direct testimony to be 10 minutes, she is being made available primarily for cross examination and will not add to Panel One's estimated 40 minutes for direct testimony.

Nancy Parker will sit on Panel Two. While Reclamation originally estimated her direct testimony to be 10 minutes, she also is being made available primarily for cross examination purposes and will not add to Panel Two's estimated 240 minutes of direct testimony.

We believe that this is the most efficient presentation of the joint-Petitioners case in chief for Part 2.
