Protestants Friends of the River and Sierra Club California request that the Hearing Officers consider the following proposed grouping and order for direct testimony and cross-examination for Part 2 of the hearing:

Protestants Friends of the River and Sierra Club California to be a group for direct and cross. The group to have a panel of Ronald Stork, Lawrence Kolb, Jonas Minton, and Deirdre Des Jardins, each an expert and each having 20 minutes to testify.

Mr. Stork testimony to include Water Fix upstream impacts and operational changes including changes to downstream fishery conditions, recreation and public trust resources, project not in public interest.

Dr. Kolb testimony to include Water Fix water quality impacts, necessity of measurable limits, and alternatives.

Mr. Minton testimony to include Water Fix water quality impacts, necessity of measurable limits, alternatives, project not in public interest.

Ms. Des Jardins testimony to include Water Fix lacks a water supply, impacts on estuary of over-allocation, and sea level rise and future demand.
