For over 100 years, with Lodi, CA, near the DELTA LOOP has been losing ground water. That is due to NorCal drought and to Oakland via Pardee Reservoir ("Pardee", wikipedia, 2014). Now, the loss is for SOIL SALINITY by reverse flows with Delta River neglect.

For pragmatism (or common sense), develop productive alternatives to Delta River destruction, that is, in any horrifying twin water tunnels (40 foot wide, 40 miles), under the Delta River of Sacramento, San Joaquin and other Delta Counties.
