Attached is a revised **Order for Cross-Examination and Group Number Assignment** that was provided in hard copy at the hearing on February 22, 2018. This document was originally issued with the January 4, 2018 [ruling letter](#). The order for cross-examination generally proceeds according to the order established in Part 1. The attached version includes minor changes to the ordering of parties within several groups to more closely reflect the order in Part 1 of the hearing. Additionally a footnote is included for the parties Bogle Vineyards/Delta Watershed Landowner Coalition (DWLC); Diablo Vineyards and Brad Lange/DWLC; and Stillwater Orchards/DWLC in group 19 that reflects the November 8, 2017 [ruling letter](#) which allowed these parties to cross-examine witnesses on Part 1 issues so long as the line of questioning directly relates to the witnesses' direct testimony in Part 2.
