CALIFORNIA WATERFIX HEARING - RULING ON OUTSTANDING OBJECTIONS FROM PART 2 REBUTTAL AND OTHER PROCEDURAL MATTERS

This ruling addresses outstanding objections from Part 2 sur-rebuttal and provides instructions for proposing corrections to hearing transcripts. We have received and reviewed parties' requests regarding the schedule for closing briefs. Another ruling regarding briefing and other procedural matters will be forthcoming.

DWR's Objections to Antioch-700

The Department of Water Resources (DWR) objected to the admission of Antioch-700 – orally on September 28, 2018, and then in writing on [October 1, 2018](#), in accordance with our direction. DWR alleges that Dr. Susan Paulsen's Opinions 1 and 2 provide no new evidence on sur-rebuttal and therefore constitute duplicative evidence beyond the scope of what our September 10, 2018 ruling allowed. The City of Antioch (Antioch) responds that, although Dr. Paulsen's Opinions 1 and 2 do rely on prior testimony in the record, they do so in support of new counter-arguments or clarifications that are responsive to rebuttal testimony submitted by Dr. Chandra Chilmakuri. Antioch's [October 2, 2018](#) written opposition includes a detailed list tying specific portions of Dr. Chilmakuri's Part 2 rebuttal testimony to corresponding responsive portions of Dr. Paulsen's Opinions 1 and 2 in Antioch-700.

We agree with Antioch that Antioch-700, while relying on some evidence already in the record, adds sufficiently new testimony that it comports with the direction provided in our September 10, 2018 ruling. The testimony itself – not merely the exhibits it cites – is the proper measure of whether or not Antioch-700 is duplicative evidence that should be excluded from the record. By identifying alleged inaccuracies in DWR-1217, Dr. Paulsen presented new testimony purporting to clarify the record as to statements she and Dr. Chilmakuri made during the case-in-chief and rebuttal phases of Part 2. She also presented argument regarding the relative weight that we should give those statements. We find that such testimony is not duplicative, and therefore overrule DWR's objections.

DWR's Objections to County of San Joaquin, et al., Exhibits

On September 27, 2018, DWR submitted [written objections](#) to several of County of San Joaquin, et al.'s (COSJ) Part 2 sur-rebuttal exhibits. DWR asserts that SJC-369 and SJC-372 are beyond the scope of the WaterFix hearing because they pertain to San Joaquin River conditions upstream of Vernalis.

DWR further objects to SJC-370, SJC-371, SJC-373, SJC-381, SJC-383, SJC-387, and SJC-388 through SJC-395 on hearsay grounds. Each of those exhibits is cited in the 2010 Delta Flow Criteria Report (SWRCB-25). Finally, DWR objects to the admission of SJC-514 and SJC-516 on the grounds that each is duplicative of another exhibit, just numbered differently.

COSJ responds that, because SJC-369 through SJC-373, SJC-381, SJC-383, SJC-387 and SJC-388 through SJC-395 all were cited and considered in the 2010 Delta Flow Criteria Report, which is in the evidentiary record, they similarly belong in the evidentiary record. COSJ also offers some clarifications and proposed solutions with respect to its two potentially duplicative exhibits. COSJ asserts that SJC-514 is the same document as SWRCB-32, but neither has been admitted into evidence. COSJ therefore moves SWRCB-32 into evidence and proposes to withdraw SJC-514 and substitute all of SJC-364's references to that exhibit with references to SWRCB-32. Similarly, COSJ observes that SJC-516 incorporates a portion of SWRCB-27. COSJ proposes to withdraw SJC-516 and substitute all of SJC-364's references to that exhibit with references to SWRCB-27.

We agree with DWR that SJC-369 and SJC-372 are beyond the scope of this hearing. Our review of those exhibits confirms DWR's assertion that those exhibits pertain solely to San Joaquin River conditions upstream of Vernalis. As we already have observed in prior rulings, the 2010 Delta Flow Criteria Report discusses a broad range of issues, some of which are relevant to this water right hearing and others that are not. The mere fact that those exhibits were cited in the 2010 Delta Flow Criteria Report does not automatically render them relevant and admissible. SJC-369 and SJC-372 will not be admitted into evidence.

We note DWR's hearsay objections to SJC-370, SJC-371, SJC-373, SJC-381, SJC-383, SJC-387, and SJC-388 through SJC-395 for the record. Those exhibits are hereby admitted to the evidentiary record subject to those hearsay objections.

We accept COSJ's proposed resolution of DWR's objections to SJC-514 and SJC-516. We hereby direct COSJ to revise SJC-364 accordingly and submit those revisions no later than **October 31, 2018**. To the extent there is any confusion as to the status of SWRCB-27 and SWRCB-32, those exhibits both are admitted into the evidentiary record.

State Water Contractors' Objections to LAND-309

On September 26, 2018, the State Water Contractors (SWC) orally objected to the admission of LAND-309. LAND-309 comprises a comment letter and six exhibits submitted for the public review draft of the environmental impact report supplement (EIR Supplement) for the WaterFix Project. SWC objected that three of those exhibits within LAND-309 – Exhibits 1, 4, and 5 – relate solely to the same topics that we had stricken from testimony by Russel Van Loben Sels as outside the scope of Part 2 sur-rebuttal. Specifically, we had ruled orally that portions of LAND-305 discussing concerns that the ultimate capacity of the WaterFix Project may exceed what is currently proposed are beyond the scope of sur-rebuttal, as are portions discussing Rosebud Rancho.

For the reasons provided in our oral ruling on LAND-305, we agree that Exhibits 1, 4 and 5 within LAND-309 are similarly beyond the scope of Part 2 sur-rebuttal. Staff will redact those portions of LAND-309 and post a revised exhibit.

Instructions Regarding Proposed Corrections to Hearing Transcripts

Hearing team staff have been posting hearing transcripts on the WaterFix [Transcripts webpage](#) as they become available. The last of the available hearing transcripts will be posted no later than October 22, 2018. Parties have until **November 15, 2018**, to submit all proposed corrections to the hearing transcripts. Proposed corrections must be substantive rather than minor typographical errors. For example, if the relevant segment of the hearing video shows that the transcript misidentified the speaker, that would be a substantive correction worthy of consideration. Each party must compile all proposed corrections into a single list that identifies the day of the hearing, the existing text, the proposed correction, and the approximate time in the hearing video when the words are spoken. (Hearing video archives are available on the State Water Board's [Board Videos webpage](#).) Corrections must be emailed to the hearing team at CWFhearing@waterboards.ca.gov. Staff will review proposed corrections and post accepted corrections to the hearing transcript well enough in advance of the due date for closing briefs that parties will have time to make any necessary corrections to hearing transcript citations.

This will be the parties' sole opportunity to propose corrections to the hearing transcripts that are available as of October 22, 2018. Proposed corrections submitted piecemeal and/or after the deadline provided above will not be considered.
