**NOTICE IS HEREBY GIVEN** that pursuant to section 1122 of the California Water Code and title 23, sections 768 and 769 of the California Code of Regulations, San Joaquin Tributaries Authority (SJTA) respectfully requests that the State Water Resources Control Board (State Water Board) reconsider the Order for Additional Information in the Sacramento and San Joaquin River Watershed and Delta (Information Order) issued on February 4, 2015.

The provisions of 879(c) of the California Code of Regulations, title 23, (section 879(c)) have not been satisfied with regard to the members of the SJTA. Specifically, the Information Order is unfounded as it relates to the SJTA members, due to the lack of complaint against SJTA members and lack of information that indicates any SJTA member is unlawfully diverting stored water. For these reasons, the SJTA members petition the State Water Board to revise the
