## RULING ON PARTICIPATION IN THE BIG SUR RIVER HEARING – APPLICATION 30166 OF EL SUR RANCH

On June 16, 2011, the State Water Resources Control Board (State Water Board) received an e-mail from you and an e-mail from your representative, Mr. Hubbard indicating that you could not participate in the hearing on June 16. You requested that you be able to testify at the hearing on July 8, 2011. I have consulted with the hearing officers and they determined that you may not present testimony since you did not submit any written testimony by the due date of May 19, 2011, as described in the January 12, 2011 hearing notice. However, you may present a policy statement at the hearing on July 8. The State Water Board requests that policy statements be provided in writing before they are presented and oral summaries of the policy statements are limited to five minutes. If you do not want to attend the hearing in person, you may submit a written policy statement any time prior to July 8, 2011.
