PLEASE NOTE

The Hidden Lakes Estates Homeowners Association (Hidden Lakes) and West Side Irrigation District (West Side) hearings were both originally scheduled for January 11, 2010. The State Water Board has received requests from Hidden Lakes and West Side to reschedule their hearings. Therefore, both hearings are now scheduled to commence on Thursday, January 28, 2010. Exhibits will be due on January 12, 2010. You will receive a "Revision to Notices of Public Hearing" that will provide formal notice of the following: (1) rescheduling of the originally scheduled hearing date; (2) change to a different hearing room; and (3) change in deadline for submittal of hearing exhibits.
